# 2. The Problems MedInfo Finder Solves

MedInfo Finder addresses critical gaps in medication management and patient awareness that impact both individual and public health:

This is especially common among older adults, who may assume these symptoms are simply due to aging.
- 3. Absence of a Practical Tracking System for Adverse Effects: There is currently no user-friendly, organized way for individuals—and their healthcare providers—to monitor potential adverse effects and long-term impacts of medications, which can result in overlooked symptoms and lead to complications.
- 4. **Risks of Drug Interactions and Over-Prescribing:** Limited appointment times, human errors, and communication gaps contribute to risks such as drug interactions, over-prescribing and serious side effects.
- 5. Inadequate Dissemination of Essential Medication Details: Patients frequently lack clear, accessible information regarding essential medication details, especially concerning inactive ingredients. These unaddressed elements, such as peanut oil, lactose, and gluten, can lead to unrecognized allergic reactions, exacerbating health issues and creating new complications. Additionally, some inactive ingredients may contain heavy metals or other compounds that can cause adverse effects. Important interactions with foods, over-the-counter drugs, and other substances are also commonly underemphasized, which can increase patient risk. Improved dissemination of these essential medication details is critical for safer, more effective medication management.
- 6. Lack of Public Knowledge on Food as Medicine: The public often lacks guidance and accessible knowledge on how specific foods can support or undermine their treatment, missing an opportunity for holistic health improvement.



7. **Misunderstanding the Role of Hydration in Medication Efficacy:** Patients often lack awareness of how hydration levels, specific to certain medications (e.g., statins), can influence treatment outcomes, particularly for

conditions impacting muscles and other bodily systems.

#### 1) Personalized Medication Reports

In alignment with MAHA's goal to improve health literacy, MedInfo Finder's platform delivers personalized, actionable insights to help individuals better understand their medications and more proactively manage their health.

#### 3) Timely Dissemination of Critical Pharmaceutical Drug Information

Similar to Children's Health Defense (CHD) and in alignment with MAHA's overall mission, MedInfo Finder's second phase will assist in the dissemination of timely information:

i) Antibiotic Awareness: Highlighting healthier antibiotic prescriptions by including probiotics (hopefully covered by insurance) and educating all medical practitioners about antibiotic resistance.



- ii) Evaluation of Drug Groups: Providing updates on new developments and data for specific drug categories, such as the reevaluation of statins and their long-term use.
- iii) Monitoring High-Profile Medications: Raising awareness about medications under review for potential recall, restriction, or safety concerns. For example, anti-obesity medications being considered for U.S. children.
- iv) Repurposing Medications: Sharing insights on the innovative use of established medications, such as repurposing anti-parasitic or anti-fungal drugs for oncology treatments.

#### 4) Identification of High-Risk Drug Interactions and Inactive Ingredients

MedInfo Finder identifies risks related to both active drug interactions and certain inactive ingredients, which can contain allergens like lactose, gluten, or peanut oil, potentially causing adverse effects in sensitive individuals. Detailed information on inactive ingredients in generic medications is, to the best of our knowledge, often harder to obtain, as this data is typically accessible to pharmacists and can be time-consuming to retrieve. Doctors may, again, lack the time to fully investigate inactive ingredients in generics, making it challenging for patients with specific allergen concerns. The report will recommend that patients consult with a pharmacist, who can provide a detailed list of inactive ingredients for each medication if needed.

#### 5) Enhanced Communication with Healthcare Providers

MedInfo Finder's reports are designed to facilitate productive discussions between patients and healthcare providers.
